Purpose and Effect of the Zoning By-Law Amendment

The property is currently zoned "Rural (RU)" in the Municipality's Comprehensive Zoning Bylaw No. B2014-070, as amended. The purpose of the proposed Zoning By-law Amendment is a condition of severance B-168-22 for a lot addition to the benefiting property municipally known as 11 Fire Route 89. The lands being added to the benefitting lands are zoned "Rural (RU)" while the benefitting lands are currently zoned "Shoreline Residential – Private Access – Special Exception - 87(SR-PA-87)". To prevent a split-zoned lot, the severed lands are being rezoned to Shoreline Residential - Private Access -Special Exception -87 (SR-PA-87) to reflect the zone category of the benefitting lot.

The applicant has submitted the following information, which is available for public review at the municipal office during regular business hours and on the website under the "Current Planning Applications" tab:

Representation and Notification

Any person may attend the in-person or electronic public meeting and make written and/or oral submissions either in support of or in opposition to the proposed amendment. It is the responsibility of the interested member of the public to have technology in place to connect to the meeting.

If a person or public body does not make written or oral submissions at a public meeting or make written submissions to the Municipality of Trent Lakes before the by-law is passed, the person or public body is not entitled to appeal the decision to the Ontario Land Tribunal (OLT).

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality of Trent Lakes before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal (OLT) unless, in the opinion of the Board, there are reasonable grounds to do so.


