Hi Gord,

It was great talking to you today. The archaeological requirements of the PPS have not changed between PPS,2005 and PPS,2020.

In PPS,2005 the relevant section is 2.6.1 which reads:

"Significant built heritage resources and significant cultural heritage landscapes shall be conserved."

In PPS,2020 the language (and section number) is identical. While our prescribed fieldwork standards have changed following the Province's release of the "Standards and Guidelines for Consultant Archaeologists" (2011), they were certainly sufficient to address the PPS in both iterations.

I pulled the report to take a look at what was found on the property, and everything except a small pre-Contact lithic fragment (some stone toolmaking debris) came from the 20th century. The location around the lithic fragment was tested intensively and yielded no further artifacts. No further work was recommended on the property. The report and its recommendations were accepted by what was then the Ministry of Tourism and Culture into their Register of Reports - which means that they agree with ARA that there are no further archaeological concerns about the property.

That Council receive the report from the Planning Consultant regarding Application for Zoning By-law Amendment (Dewdney Mountain Farms); and further

That, at this time, the application for zoning by-law amendment submitted by Dewdney Mountain Farms Limited not be declared complete; and further

That Council direct staff to request the applicant submit a statement from the originators of the original four studies, being the Hydrogeological Report, Environmental Impact Study, Blasting Impact Study, and Archeological Study, to confirm that they comply with the current Provincial Policy Statement, reflect the operation of both dimensional stone and aggregate, and are still valid today given the new residential development in the area; and further

That Council direct staff to request the applicant provide an up-to-date set of ARA site plans which reflect evidence and commitments relied upon in prior OMB decisions to approve OPA 41; and further

That Council determines complete the haul route agreement proposal.
