An application for an entrance permit **must be** accompanied with an application fee of **\$100.00** (*includes processing, initial approval and final inspection*) **plus** a deposit fee of **\$750.00** (*refundable after final inspection is approved*). If a re-inspection is required, there is a fee of \$100 per visit (*failure to comply with approval or final inspection*).

The deposit fee will be refunded after the entrance has been installed as follows:

1. The culvert, if required, is set to the approved ditch grade.
2. Granular backfill is placed around the culvert and used to shape the entranceway.
3. Granular "A" type gravel to be used to top driveway.
4. The culvert size and entranceway width are as specified in the permit.
5. The roadside is left in a neat and tidy condition. Slopes must be neatly trimmed with topsoil and not steeper than 2:1. Culvert ends must be clean.
6. An entrance installed on a temporary permit is removed.
7. Only new C.S.P. will be accepted.
8. Entrance must be completed within two (2) years from the date of application, **or deposit funds will be forfeited.**
