



**NOTICE OF 2<sup>nd</sup> PUBLIC MEETING  
CONCERNING A PROPOSED  
OFFICIAL PLAN AMENDMENT  
AND ZONING BY-LAW AMENDMENT**

**TAKE NOTICE** that the Council of the Municipality of Trent Lakes will hold a second public meeting to consider a proposed Official Plan Amendment and Zoning By-law Amendment under Section 22 and 34 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended. **Note – these applications were originally the subject of a public meeting on July 11, 2017.**

***The 2<sup>nd</sup> Public Meeting is at the direction of Council who deem it in the public's best interest to identify proposed changes by the applicant to the original application submission, which includes an increase to the number cabins from 12 to 28, an open-air pavilion and proposed walking trail location.***

**Purpose and Effect**

The subject lands are currently designated and zoned "Rural" and "Environmental Protection" in the Trent Lakes Official Plan and Comprehensive Zoning By-law No. B2014-070, as amended. A recreational use has been established on the subject lands in the form of a mountain bike trail system that has been operational for a number of years. The owners have proposed to add new buildings and facilities to the support the trail system, including 28 sleeping cabins, a 372 m<sup>2</sup> (4,000 ft<sup>2</sup>) mess/assembly hall, a shower and bathroom facility, an open-air pavilion and a walking trail. Access is proposed off Bolton's Road, via County Road 36, with a proposed parking lot on the site to provide off-street parking. The applicant has agreed to upgrade Bolton Road, to the satisfaction of the Municipality.

**Representation and Notification**

Any person may attend the public meeting and make written and/or oral submissions either in support of or in opposition to the proposed amendment.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality of Trent Lakes before the by-law is passed, the person or public body is not entitled to appeal the decision of the Council of the Municipality of Trent Lakes to the Ontario Municipal Board.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Municipality of Trent Lakes before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

If you wish to be notified of the decision of the Council of the Municipality of Trent Lakes on the proposed zoning by-law amendment, you must make **a written request** to the Municipality of Trent Lakes, at 760 County Road 36, Trent Lakes, Ontario, K0M 1A0.
