#### Purpose and Effect of the Zoning By-Law Amendment

The property is currently zoned "Rural (RU) and Shoreline Residential – Private Access (SR-PA) in the Municipality's Comprehensive Zoning By-law No. B2014-070, as amended. The primary purpose of the application is to zone a portion of the lands to a Tourist Commercial (TC) Exception Zone in a manner that recognizes the existing seasonal camp on the subject lands which has been a long-standing use. The amendment will also permit the construction of a new manager's residence with a floor area of 53 sq. m. (576 sq. ft.)

The applicant has submitted the following information, which is available for public review at the municipal office during regular business hours and on the website under the "Current Planning Applications" tab:

1. Topographic Plan of Survey of the North East portion of the camp prepared by Elliott and Parr dated September, 2025;
2. A Site Plan prepared by the Applicant dated December, 2025;
3. Proposed Floor Plans of Manager's Residence prepared by the Applicant dated February, 2025;
4. Existing Structures floor plans prepared by Wilcox Architects Inc dated 2010;

## **Representation and Notification**

Any person may attend the in-person or electronic public meeting and make written and/or oral submissions either in support of or in opposition to the proposed amendment. In order to participate electronically, please register for the webinar. The link is provided in the agenda for the regular Council meeting on Tuesday, February 24<sup>th</sup>, 2026, which can be found at [calendar.trentlakes.ca/meetings](http://calendar.trentlakes.ca/meetings). It is the responsibility of the interested member of the public to have technology in place to connect to the meeting.

If a specified person or public body does not make written or oral submissions at a public meeting or make written submissions to the Municipality of Trent Lakes before the by-law is passed, the specified person or public body is not entitled to appeal the decision to the Ontario Land Tribunal (OLT).

If a specified person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality of Trent Lakes before the by-law is passed, the specified person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal (OLT) unless, in the opinion of the Board, there are reasonable grounds to do so.

If you wish to be notified of the decision of the Council of the Municipality of Trent Lakes on the proposed Zoning By-law Amendment, you must make a written request to the Municipality of Trent Lakes, at 760 County Road 36, Trent Lakes, Ontario, K0M 1A0.
