Purpose and Effect of the Zoning By-Law Amendment

The proposed amendment is a requirement of provisional approval for consent applications B-119-24 and B-120-24 for the creation of two residential lots. The property is currently zoned "Rural (RU)" in the Municipality's Comprehensive Zoning By-law No. B2014-070, as amended. The proposed lot sizes do not conform to the current Rural (RU) zoning of the property; therefore, the purpose of the proposed Zoning By-law Amendment is to rezone the two proposed residential lots from the "Rural (RU)" Zone to the "Rural Residential (RR)" Zone to achieve conformity with the Municipality's Comprehensive Zoning By-law.

The applicant has submitted the following Registered Plan, which is available for public review at the municipal office during regular business hours and on the website under the "Current Planning Applications" tab:

Representation and Notification

Any person may attend the in-person or electronic public meeting and make written and/or oral submissions either in support of or in opposition to the proposed amendment. If a specified person or public body does not make written or oral submissions at a public meeting or make written submissions to the Municipality of Trent Lakes before the by-law is passed, the specified person or public body is not entitled to appeal the decision to the Ontario Land Tribunal (OLT).

If a specified person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality of Trent Lakes before the by-law is passed, the specified person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal (OLT) unless, in the opinion of the Board, there are reasonable grounds to do so.

If you wish to be notified of the decision of the Council of the Municipality of Trent Lakes on the proposed Zoning By-law Amendment, you must make a written request to the Municipality of Trent Lakes, at 760 County Road 36, Trent Lakes, Ontario, K0M 1A0.
