#### **Purpose and Effect of the Zoning By-Law Amendment**

The property is currently zoned “Shoreline Residential (SR)” in the Municipality’s Comprehensive Zoning By-law No. B2014-070, as amended. The amendment is a requirement of provisional approval for consent application B-73-23 for the creation of a residential lot. The proposed lot does not conform to the current Shoreline Residential zoning of the property as the severed parcel no longer abuts Little Bald Lake; therefore, the purpose of the proposed Zoning By-law Amendment is to rezone the proposed residential lot from the “Shoreline Residential (SR)” Zone to the “Rural Residential (RR)” Zone to achieve conformity with the Municipality’s Comprehensive Zoning By-law.

The applicant has submitted the following Registered Plan, which is available for public review at the municipal office during regular business hours and on the website under the “Current Planning Applications” tab:

1. Registered Plan 45R-17881
2. Natural Heritage Evaluation prepared by GHD dated July 5, 2024
3. Peer Review of Natural Heritage Evaluation by Stantec Consulting Ltd dated March 5, 2024.
4. Second Peer Review of updated Natural Heritage Evaluation by Stantec Consulting Ltd dated September 19, 2024.

#### **Representation and Notification**

Any person may attend the in-person or electronic public meeting and make written and/or oral submissions either in support of or in opposition to the proposed amendment. In order to participate electronically, please register for the webinar. The link is provided in the agenda

If a specified person or public body does not make written or oral submissions at a public meeting or make written submissions to the Municipality of Trent Lakes before the by-law is passed, the specified person or public body is not entitled to appeal the decision to the Ontario Land Tribunal (OLT).

If a specified person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality of Trent Lakes before the by-law is passed, the specified person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal (OLT) unless, in the opinion of the Board, there are reasonable grounds to do so.

If you wish to be notified of the decision of the Council of the Municipality of Trent Lakes on the proposed Zoning By-law Amendment, you must make a written request to the Municipality of Trent Lakes, at 760 County Road 36, Trent Lakes, Ontario, K0M 1A0.
