Purpose and Effect of the Zoning By-Law Amendment

The proposed amendment is a requirement of provisional consent for application B-55-24 which facilitated a lot line addition. The property is currently zoned “Hamlet Residential (HR)” and “Development (D)” in the Municipality’s Comprehensive Zoning By-law No. B2014-070, as amended, and is part of a Settlement Area. The subject lands are proposed to be rezoned to a “Hamlet Commercial Exception Zone” to facilitate the proposed development of a self-storage facility at the southern extent of the property adjacent to the Municipality’s Works Yard. Should the proposed development be approved, the land will be subject to Site Plan Control.

The applicant has submitted the following information which is available for public review at the municipal office during regular business hours and on the website under the “Current Planning Applications” tab:

1. Site Plan
2. Registered Plan 45R-17937 prepared by IBW Surveyors dated October 2025.
3. Storage Facility Planning Justification Report prepared by Ecovue Consulting dated April 2026.
4. Environmental Impact Study prepared by Riverstone dated January 2026.
5. Stormwater Management Brief prepared by M.V. Wilson Engineering Inc dated February 2026.
6. Traffic Brief prepared by Nextrans Consulting Engineers dated February 2026.

Representation and Notification

Any person may attend the in-person or electronic public meeting and make written and/or oral submissions either in support of or in opposition to the proposed amendment. In order to

participate electronically, please register for the webinar. The link is provided in the agenda for the regular Council meeting on Tuesday, August 4th, 2026, which can be found at calendar.trentlakes.ca/meetings. It is the responsibility of the interested member of the public to have technology in place to connect to the meeting.

If a specified person or public body does not make written or oral submissions at a public meeting or make written submissions to the Municipality of Trent Lakes before the by-law is passed, the specified person or public body is not entitled to appeal the decision to the Ontario Land Tribunal (OLT).

If a specified person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality of Trent Lakes before the by-law is passed, the specified person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal (OLT) unless, in the opinion of the Board, there are reasonable grounds to do so.

If you wish to be notified of the decision of the Council of the Municipality of Trent Lakes on the proposed Zoning By-law Amendment, you must make a written request to the Municipality of Trent Lakes, at 760 County Road 36, Trent Lakes, Ontario, K0M 1A0.
