**AND FURTHER, TAKE NOTICE** that the Council of the Municipality of Trent Lakes will hold a public meeting to consider the proposed Zoning By-law Amendment under Section 34 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

#### **Purpose and Effect of the Zoning By-Law Amendment**

The property is currently zoned "Tourist Commercial-5 (TC-5)" in the Municipality's Comprehensive Zoning By-law No. B2014-070, as amended. The amendment from TC-1 to TC-5 was approved by By-law B2020-028.

The purpose of the application is to amend the special exception zone to permit the construction of two open air attached decks for rental cottages #6 & #7 in the water yard, and to recognize an existing open air attached deck for rental cottage #2 in the water yard. The applicant will require the following relief:

- a reduction to the water yard setback to recognize an existing open-air deck from 30 m (98.4 ft.) to 22 m (73 ft.) for Cottage 2 with a total floor area of 31.67 sq. m (341 sq. ft.);
- a reduction to the water yard setback for the proposed open-air deck from 30 m (98.4 ft.) to 13.7 m (45 ft.) for Cottage 6 with a total floor area of 15.3 sq. m (165 sq. ft.); and
- a reduction to the water yard setback for the proposed open-air deck from 30 m (98.4 ft.) to 17.4 m (57 ft.) for Cottage 7 with a total floor area of 15.14 sq. m (163 sq. ft.).

**Representation and Notification**

Any person may attend the in-person or electronic public meeting and make written and/or oral submissions either in support of or in opposition to the proposed amendment. It is the responsibility of the interested member of the public to have technology in place to connect to the meeting.

If a specified person or public body does not make written or oral submissions at a public meeting or make written submissions to the Municipality of Trent Lakes before the by-law is passed, the specified person or public body is not entitled to appeal the decision to the Ontario Land Tribunal (OLT).

If a specified person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality of Trent Lakes before the by-law is passed, the specified person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal (OLT) unless, in the opinion of the Board, there are reasonable grounds to do so.

If you wish to be notified of the decision of the Council of the Municipality of Trent Lakes on the proposed Zoning By-law Amendment, you must make a written request to the Municipality of Trent Lakes, at 760 County Road 36, Trent Lakes, Ontario, K0M 1A0.
